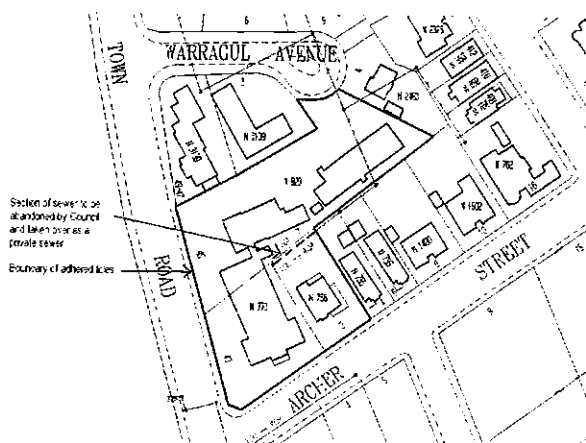

### WATER MANAGEMENT ACT 1999

#### Part 14A

#### DECLARATION OF WATER SUPPLY EMERGENCIES

I, DAVID LLEWELLYN, being and as the Minister for the time being administering the *Water Management Act 1999*, in exercise of the power conferred upon me by Section 280B of the Act hereby declare a water supply emergency.

For the purposes of this declaration I specify that:

1. The essential town water supply needs of Bothwell, the stock and domestic water supply needs of riparian landowners on the River Clyde and water supply needs for the purposes of firefighting cannot be met within the provisions of the Lakes Sorell and Crescent Water Management Plan.
2. The water supply emergency will be in effect from the date of this declaration until 31 May 2008.
